### ACTIONS TAKEN AT 4.30.20 EXECUTIVE COMMITTEE

#### Cyber attack update

• Minner Labrador, UCC president, gave an update on the malicious cyber-attack that affected UCC network servers earlier this month. The attack affected office email, telephones, website, and network files. Art Lenz, his colleagues and associate, Tim Shafer, have been working diligently to make the server operational again.

#### Hope Awakens update

• President Labrador announced that the Hope Awakens seminars from It Is Written have so far resulted in more than 40,000 that have pre-registered. Twenty-eight UCC congregations are participating in this exciting, unprecedented series.

#### Virtual campmeeting

• President Labrador gave an update on plans for a virtual campmeeting to be hosted at Spokane Valley Adventist Church. Details will be forthcoming.

#### Financial contingency plans

• Allee Currier, UCC vice president for finance, reported on a tithe increase this quarter. Jan and Feb were record high months for tithe. March however, showed a 20% decrease. A financial contingency plan was presented from the administration and finance committee to meet a potential tithe drop up to 10% for 2020. Unemployment is at record high and may impact UCC families.

#### Immediate implementation

In anticipation of a 3% annual tithe loss, the following steps were recommended:

- Move camp meeting to virtual environment
- Defer 1.6 percent pay increase
- Postpone evangelism director position
- Summer events cancelled or rescheduled

#### (Reduction in travel and lodging costs)

- Lower mileage reimbursement rate
- Fill open vacancies, freeze hiring on new positions Immediate savings: \$400,000

#### Phase 1 implementation

In anticipation of a 3 - 6% annual tithe loss (budget loss up to \$1,000,000), the following steps were recommended:

- Defer ERI increase
- 20% reduction in departmental programs
- Voluntary retirements/attrition
- Office work force reassignments and reductions
- Redraw districts/Follow ministerial staffing guidelines

- Additional administrative cuts, while still maintaining mission excellence and services to churches and schools of UCC.

Phase 1 savings:	\$575,000
Total savings:	\$975,000

• It was voted to approve the immediate implementations and Phase 1 of the financial contingency plan. Should the tithe shortfall be greater than 6%, a Phase 2 contingency plan is under development and will be revisited at a later date.

#### **Education update**

• Brian Harris, UCC vice president for education, gave a report on the implementation of remote learning. Resources are being provided to teachers, families and students. Progress continues with Vision 2020, and a survey will be sent to pastors for sharing with constituents this spring.

• The impact of COVID-19 on our UCC schools has resulted in an average loss of almost 2 students per school.
